Please find enclosed a copy of Ministerial Order (MO) No. H:007/2021 amending the Schedule "A" of the North Peace Housing Foundation (NPF).

Further to your discussions with your Housing Advisor, Dora Fitz, the Schedule "A" has been updated to reflect:

- Changing ownership of properties, which were Nominal Sum Dispositioned to NPF in March 2019.
  - Land in Fairview for the house that burned down was previously removed in error.
- Change in legal description for the Grimshaw 3 project due to an administrative error noted.
- Change the street address for two properties in Manning due to an error noted during reconciliation of our information.
- Changing the land owner and building owner information for Peace River 1 and Manning 1 as these properties were transferred to the Alberta Social Housing Corporation under the Social Housing Agreement.
- Transfer the Rural and Native Housing Program units to the Community Housing Program and renaming them.
- Administrative changes to Peace River 3 due to duplication in addresses.
